# **Chairperson's Report:**

We made it through another year under budget with measurable forward progress, thanks to the work of the respective Subcommittees. Special thanks to long time Commissioner Sharon Wilcox, who is not returning after years of service.

## **Committee Reports:**

<u>Central Beach Improvement</u>: The committee budget of 3,500 dollars enabled removal of the invasive willow grove, with the felled trees and remaining roots removed by Tuck Excavating. This opens the beach area considerably. Tuck also transported nine yards of gravel to the beach that was spread with the help of volunteers, who also pulled the Scotch Broom from the beach and parking lot perimeters.

Further beach work had been planned, as well as installation of a volleyball net on the upper lawn, but this was not completed because information regarding our budget balance could not be obtained in a timely fashion.

The balance therefore remains and we plan to use it to complete the beach resurfacing. Because we are informed that a volleyball net may only be installed after a proper court is in place, with an approximate cost of 10,000 dollars, that part of the project will be placed on hold.
